
विषय : विद्यालय को स्थायी मान्यता प्रदान किये जाने के सम्बन्ध में।

शासनादेश संख्या 419/79-6-2013-18 (20)/91 दिनांक 08.05.2013 में दिये गये निर्देश के क्रम में मान्यता समिति के अनुमोदनोपरान्त इस कार्यालय के पत्रांक : बेसिक/8834-36/2015-16 दिनांक 22.12.2015 के द्वारा महात्मा जे०एफ० पब्लिक स्कूल, मण्डुआडीह, वाराणसी को दिनांक 01.07.2015 से 31.03.2018 तक 03 वर्ष की अवधि तक के लिए कक्षा-नर्सरी से 8 तक के लिए अनन्तिम अंग्रेजी माध्यम की मान्यता प्रदान की गयी थी। इस सन्दर्भ में आपने अपने पत्र दिनांक 30.12.2017 के द्वारा अन्य पत्रजात की प्रति संलग्न करते हुए विद्यालय की मान्यता को नवीनीकृत किये जाने हेतु पत्रावली प्रस्तुत की गयी है। पत्रावली के परीक्षणोपरान्त एवं दिनांक 01.07.2015 से 31.03.2018 के बीच मान्यता की शर्तों के उल्लंघन से सम्बन्धित कोई प्रतिकूल तथ्य संज्ञानित नहीं हुआ। उक्त विद्यालय दिनांक 01.09.2003 से 30.08.2032 तक की अवधि के लिए रजिस्टर्ड किरायेदारी के आधार पर संचालित किया जा रहा है।


